### VILLAGE OF PLEASANT PRAIRIE UNIFORM SECONDHAND ARTICLE/JEWELRY DEALER LICENSING GUIDELINE

The guideline assists in the determination of whether or not an applicant is qualified for a Secondhand Article/Jewelry License with respect to the results of a criminal background check conducted by the Village of Pleasant Prairie Police Department.

Has the applicant been convicted of a felony crime within the past ten (10) years; or, a misdemeanor crime, statutory violation punishable by forfeiture or County or Municipal Ordinance violation within the past five (5) years wherein any of the following apply:

- 1. Weapons of any kind were used, displayed or threatened.
- 2. Physical violence was use or threatened.
- 3. The incident giving rise to the conviction involved robbery, burglary, theft or other misappropriation of property or money.
- 4. The incident giving rise to the conviction involved the possession or receiving of stolen property or goods.
- 5. The incident giving rise to the conviction involved fraud or fraudulent dealing.
